**AN ORDINANCE LEVYING A TAX RATE  
FOR THE COUNTY OF MORRIS  
FOR THE TAX YEAR 2018**

BE IT ORDAINED AND ORDERED by the Commissioner's Court of Morris County that:

We, the Commissioner's of Morris County do hereby levy or adopt the rate on each \$100.00 worth of property located within the County of Morris, made taxable by law, for the tax year 2018 as follows:

Road & Bridge Fund	<u>085367</u>
<b>TOTAL TAX RATE</b>	<u><b>491056</b></u>

WHEREAS, these funds are necessary and appropriate for the funding of the 2018-2019 Morris County budget, and

WHEREAS, said budget has been heretofore adopted by the Commissioner's of Morris County, and WHEREAS, all items required by law to be done have been done properly by the appropriate officials, IT IS HEREBY RESOLVED, by affirmative vote of the Commissioner's of Morris County, Texas, at a regular meeting held in the Commissioner's Courtroom of the Morris County Courthouse in Daingerfield, TX on the \_\_\_\_ day of September, 2018.

THIS YEAR'S LEVY TO FUND MAINTENANCE AND OPERATIONS EXPENDITURES EXCEEDS LAST YEAR'S MAINTENANCE AND OPERATIONS TAX LEVY. ALSO, THIS YEAR'S M&O TAX RATE IS HIGHER THAN THE EFFECTIVE MAINTENANCE AND OPERATIONS TAX RATE.

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

THE TAX RATE WILL EFFECTIVELY BE RAISED BY 4.24 PERCENT AND WILL DECREASE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$0.39.

THE MORRIS COUNTY APPRAISAL DISTRICT is hereby authorized to assess and collect the taxes of Morris County by the vote below:
